# Kansas City Nonprofit Sector at a Glance 2018



# **Number of Nonprofits**

There were 8,997 nonprofits registered as 501c3s in the Kansas City metropolitan area, an increase of 3.3 percent since 2017. Only 30.9 percent of registered 501c3s were required to file with the Internal Revenue Service. The following analysis takes a deeper look at these **2,777 charitable nonprofits**.



### **Income & Assets**


Annual income was \$15.1 billion, a decrease of 2.8 percent. Total assets were \$28.7 billion, an increase of 20.8 percent.





# **Share of Economy**

The charitable nonprofit sector share of the metropolitan economy was 11.5 percent, down half a percent from 2017.





# Foundations and Philanthropy

While 93.4 percent of foundations in the Kansas City metropolitan region were independent, community foundations accounted for one-quarter of total assets and over half of total giving in 2016, according to the most recent data.

Total income of charitable nonprofits divided by Gross Domestic Product for the Kansas City metropolitan area, also called Gross Metropolitan Product (GMP)






# **Distribution of Nonprofits**

The top five classifications were Human Services, Public/Societal Benefit, Education, Health and Arts/Culture/Humanities.



Health organizations brought in 44.6 percent of annual income, but only accounted for 8.8 percent of organizations.





# **Metropolitan Comparison**

Kansas City was on par with metropolitan areas with similar population in two categories, nonprofit organizations per 1,000 people and sector share of GMP. However, Kansas City ranked lowest in total income and total assets.
