### **\$2,500 Scholarship -Student Entrepreneur of the Year**

#### **Student Entrepreneur of the Year Scholarship**

Each year the Bloch School's Regnier Institute Advisory Council gives a \$2500 scholarship to a Bloch School student for significant entrepreneurial achievement. The winner will be announced by October 15, 2021. The scholarship recipient will be expected to participate in and help market the annual Entrepreneur of the Year Awards on November 2, 2021. They will give a short speech during the event. The event will be held at the Copekan Theater at the H&R Block Headquarters from 5:00-8:00pm.

#### **Scholarship Eligibility**

- Must be a degree-seeking student at the Henry W. Bloch School of Management (major or minor)
- Must be a student in good academic standing (minimum 3.0 grade point average)
- Must be an undergraduate or Master's student.

#### **Scholarship Criteria**

The scholarship winner will be selected based on the following criteria:

1. *Entrepreneurship Performance*: The five key elements of creativity, originality, risk taking, action/results orientation and persistence will be evaluated.
  - (1) Demonstrated entrepreneurial skills in overcoming an obstacle(s) to achieve a goal
  - (2) Actively participated in the Regnier Institute for Entrepreneurship and Innovation's entrepreneurship activities.
2. *Academic Performance*: Minimum 3.0 grade point average

#### **Scholarship Application Packet**

Applications are accepted in the Fall Semester only.

The completed scholarship application packet must include the following:

- Completed scholarship application form (please type or print legibly)
- 500-word essay describing how you have engaged in entrepreneurship academically and in your life.
- Current copy of your resume
- One faculty or professional recommendation letter
